Diabetic Foot care	Routine foot care visits, one pair of therapeutic shoes or two shoe inserts per year (up to \$150 annually). Must use approved network.	All eligible members	Authorization required. Care Coordinator will coordinate.
Memory alarms and devices	Additional home security devices such as door/window alarms and memory devices, bed alarms, chimes, and “baby monitor” type devices. Must use approved network.	All eligible members diagnosed with dementia or Alzheimer’s disease.	Authorization required. Care Coordinator will coordinate.
Pest Control	Pest control services (excluding termite inspections) covered for up to three visits per year with a \$50 maximum per trip. Max of \$150 per year (within 365 days of initial service). Must use approved network.	All eligible members living in a private residential home without the ability or capacity to perform function.	Authorization required. Care Coordinator will coordinate.

Home Delivered Meals	Up to two meals a day for up to seven days. Must use approved network.	All eligible members > 21 years of age, post-discharge from inpatient stay or transitioning from a nursing home to the community.	Authorization required. Care Coordinator will coordinate. Service limits.
