What is Measured in Each Performance Area?

Doctors' Communication

- Doctors explain things well to members
- How happy members are with their doctors
- Doctors involve the family in their child's care

Access and Preventive Care

- Members get the care they need, when they need it
- Members get breast cancer screenings
- Members get the right medicines and services

Behavioral Health

- Members with behavioral health conditions get the follow-up care they need

Medication Management

- Members get the medicines they need
- Members on certain medicines get the tests they need

The 2020–2021 Virginia CCC Plus MCO Consumer Decision Support Tool utilizes results from Healthcare Effectiveness Data and Information Set (HEDIS®) and Consumer Assessment of Healthcare Providers and Systems (CAHPS®). Calendar year 2019 data were used to derive 2020 reporting year rates. This report was compiled by Health Services Advisory Group, Inc. (HSAG) in collaboration with the Department of Medical Assistance Services (DMAS).

About the Accreditation Levels

Accreditation levels as of November 2020 are based on compliance with the National Committee for Quality Assurance's (NCQA's) rigorous requirements and the MCOs performance on HEDIS® measures. The highest level of accreditation an MCO can receive is Accredited, followed by Provisional. Interim accreditation is for new MCOs.
